# EHS Compliance Regulations in Chicago, IL

#### **Chicago Environmental Protections Ordinance (CEPO)**

The CEPO was enacted in 1992. It requires businesses to follow strict environmental regulations. The Chicago Department of Public Health (CDPH) enforces these rules.

- 1. 1992 CEPO enacted, introducing strict environmental regulations for businesses in Chicago.
- **2.** Ongoing CDPH continuously enforces regulations covering air quality, water quality, and waste management.
- **3.** Presently, Businesses and individuals must comply to ensure safety for themselves, employees, and the community.

#### **Clean Air Act Chicago**

The Clean Air Act aims to reduce pollution and improve air quality. It regulates emissions from vehicles, industries, and construction sites. The CDPH conducts regular air quality monitoring.

#### **Clean Water Act Implementation**

The Clean Water Act regulates pollutant discharge into water bodies. CDPH collaborates with the Illinois Environmental Protection Agency. Together, they ensure Chicago's water is safe for consumption and recreation.
